Contest Rules & Regulations

KDAY Radio, LLC, and its subsidiaries and affiliated companies ("referred as "93.5 KDAY" radio station), periodically conducts contests that are subject to these General Contest Rules & Regulations ("Rules"). By participating in a contest each participant agrees to these Rules and the following terms and conditions:

- 7. - 12. By accepting a prize, winner agrees to release and hold Station and sponsors harmless from any and all losses, damages, rights, claims and actions of any kind resulting from acceptance, possession or use of any prize, including without limitation, personal injuries, death and property damage. By participating in a contest, participants agree to be bound by these Rules.
